You will need to provide the following original (not photocopies) documents (photocopies are not accepted):

One document from group 1.

**Two further documents** from either group 1, 2a or 2b.

### Any current and valid passport

### • Biometric UK residence permit

## GROUP

- Current driving licence photocard Full or provisional. (UK, Isle of Man, Channel Islands and EU).
- Birth certificate (issued within 12 months of birth) Full or short form acceptable, including those issued by UK authorities overseas, such as embassies, High Commissions and HM Forces. (UK, Isle of Man and Channel Islands).
- Adoption certificate (UK and Channel Islands).
- Current UK driving licence old style paper version issued before 1998.

## **GROUP 2a**

- Current non-EU photo driving licence Full or provisional. (excluding Isle of Man and Channel Islands).
- Birth certificate (issued after time of birth) (UK, Isle of Man and Channel Islands). Full or short form acceptable, including those issued by UK authorities overseas, such as embassies, High Commissions and HM Forces.
- Marriage or civil partnership certificate (UK, Isle of Man and Channel Islands)
- **HM Forces ID card** (UK).
- Firearms licence (UK, Isle of Man and Channel Islands)
- Mortgage statement (UK or EEA)\*\*
- Bank or building society statement (UK, Channel Islands or EEA)\*
- Bank or building society account opening confirmation letter (UK, Channel Islands or EEA)\*
- Credit card statement (UK or EEA)\*
- Financial statement e.g. pension or endowment (UK)\*\*
- P45 or P60 statement (UK and Channel Islands)\*\*
- Council tax statement (UK and Channel Islands)\*\*
- Work permit or visa Valid up to expiry date. (UK) \*\*

# **GROUP 2b**

- Letter of sponsorship from future employment provider. (Non-UK or non-EEA only valid only for applicants residing outside of the UK at time of application).
- Utility bill Not a mobile telephone. (UK)\*
- Benefit statement e.g. child benefit, pension. (UK)\*
- Document from central, local government, government agency or local council giving entitlement e.g. from the Department of Work and Pensions, the Employment Service, HM Customs & Revenue. (UK and Channel Islands)\*
- Valid EU National ID card
- Valid card carrying the PASS accreditation logo (UK, Isle of Man and Channel
- Valid letter from head teacher or college principal for 16-19 year olds in full -time education. Only used in exceptional circumstances if other documents cannot be provided. (UK)
